

Target Market Determination – CPF Diversified Property Fund

Target Market Summary

This product is likely to be appropriate for a consumer seeking capital growth and income distribution through exposure to a portfolio of property related assets, to be used as a core or satellite component within a portfolio. The product is likely to be appropriate for a consumer that has a medium or long investment timeframe, and high or very high risk/return profile that does not need frequent access to capital. This product is not appropriate for consumers requiring frequent access to their capital.

Investment products and diversification

In such circumstances, the product should be assessed against the consumer's attributes for the relevant portion of the portfolio, rather than the consumer's portfolio as a whole. For example, a consumer may seek to construct a conservative portfolio with a satellite/small allocation to growth assets. In this case, it may be likely that a product with a *High* or *Very High* risk/return profile is consistent with the consumer's objectives for that allocation notwithstanding that the risk/return profile of the consumer as a whole is *Low* or *Medium*. Whether or not a dealing is significant is a matter to be determined in the circumstances of each case and must be determined having regard to ASIC's policy in RG 274.
