The May 2007 performance of the underlying investment portfolio (excluding the effect of the capital raising) was +2.40%.

### **Market Commentary**

Global equity markets notched up modest gains in April as investors reacted positively to more accommodative central bank policies and increasing commodity prices. The energy sector continued to outperform as oil prices climbed due to the decline in US inventories and diminishing concerns of a sharp economic slowdown in China. Overall, the S&P 500 Index increased 0.4% and the MSCI World index finished the month up 0.7%.

### **Performance Commentary**

The Everest Alternative Investment Trust was down 0.6% for the month of April (net of all fees and expenses). The underlying portfolio was down 0.7% in USD terms and the depreciation in the Australian dollar (from 0.766 to 0.760) added 0.7% to the total Fund performance. This compares to monthly returns for the S&P 500 Index of 1.1% (in AUD terms) and the S&P/ASX 200 Accumulation Index of 3.4%.

The Funds Multi Strategy managers had a somewhat challenging month. The Funds two largest exposures, the TPG Axon Side Pocket and the Eton Park Side Pocket, were down 0.3% and 0.8% respectively. In aggregate, these two positions detracted 0.2% from the total Fund return.

# **Fund Update**


The Fund paid a distribution of 0.99 cents per unit on 29 January 2016. The 0.99 cents per unit paid in January was reflected in the January 2016 price.


