Fund Update

The RE issued a product disclosure statement for the Fund dated 28 April 2016 (**PDS**). The purpose of this Update is to update the PDS with information which does not include any materially adverse information.

1. In the PDS the Investment Manager is listed as DirectMoney Investment Management Pty Ltd (ACN 604 346 189) (Authorised representative no. 473725) (**Investment Manager**).

Effective 14 February 2018, the Investment Manager has changed its name to Wisr Investment Management Pty Ltd. There are no other changes to the Investment Manager. The ACN and Authorised representative no. for the Investment Manager remain the same.

All entries to the Investment Manager in the PDS are to be read as Wisr Investment Management Pty Ltd (ACN 604 346 189)

2. In the PDS the Servicer is listed as DirectMoney Loans Servicing Pty Ltd (ACN 604 347 033) (**Servicer**).

Effective 14 February 2018, the Servicer has changed its name to Wisr Loans Servicing Pty Ltd. There are no other changes to the Servicer. The ACN for the Servicer remains the same.

All entries to the Servicer in the PDS are to be read as Wisr Loans Servicing Pty Ltd (ACN 604 347 033).



3. In the PDS the Credit Manager is listed as DirectMoney Credit Management Pty Ltd (ACN 604 841 750) (**Credit Manager**).

Effective 14 February 2018, the Credit Manager has changed its name to Wisr Credit Management Pty Ltd. There are no other changes to the Credit Manager. The ACN for the Credit Manager remains the same.

All entries to the Credit Manager in the PDS are to be read as Wisr Credit Management Pty Ltd (ACN 604 841 750).

4. In the PDS the DirectMoney Parent is listed as DirectMoney Limited (ACN 004 661 205) (**DirectMoney Parent**).

On 28 February 2018, the shareholders of the DirectMoney Parent voted at an EGM to approve a name change to Wisr Limited which is anticipated to come into effect around 12 March 2018. The ASX ticker will change from DM1 to WZR. The ACN for the DirectMoney Parent will remain the same.

All entries to the DirectMoney Parent in the PDS are to be read as Wisr Limited (ACN 004 661 205).

5. In the PDS the Seller is listed as DirectMoney Finance Pty Ltd (ACN 119 503 221) (AFSL 458572) (ACL 458572) (**Seller**).

On 28 February 2018, the shareholders of the DirectMoney Parent voted at an EGM to approve a name change to Wisr Limited which is expected to come into effect around 12 March 2018. As part of this, the Seller name will also change to Wisr Finance Pty Ltd. The ACN, AFSL and ACL for the Seller remain the same.

All entries to the Seller in the PDS are to be read as Wisr Finance Pty Ltd (ACN 119 503 221).
