### Investment products and diversification

<b>Consumer's need to withdraw money</b>		
Daily	Amber	The Fund is expected to be liquid at all times and investors will normally be able to request to redeem on any Business Day with proceeds usually paid within 10 days. The Fund's constitution allows 30 days to decide to accept a request and a further up to 21 days to pay the proceeds, however this has not occurred to date. In certain circumstances, such as a freeze on withdrawals or where the Fund is not liquid (as defined in the Corporations Act), there may be a cap on withdrawals for an aggregate value of more than 5% of NAV or investors may not be able to withdraw their investment during the usual period. This has not occurred to date and is considered very unlikely. Investors will be able to redeem units in the Fund on any Business Day, being a day other than a Saturday or Sunday on which the ASX is open for trading.

## Appropriateness

The Issuer has assessed the product and formed the view that the product, including its key attributes, is likely to be consistent with the likely objectives, financial situation and needs of consumers in the target market as described above, as the features of this product in Column 3 of the table above are likely to be suitable for consumers with the attributes identified with a green TMD Indicator in Column 2.

The Issuer considers that the distribution conditions below will make it likely that the investors who acquire units in the Fund are in the target market because of the following:

- The Fund's communications and website content is directed towards consumers in the Fund's target market.
- Direct investors: Investor will only be admitted to the Fund on completion of an approved application form
  - **(Paper Application)** for those investors that are Retail clients, the paper application form includes certain filtering questions and alerts relevant to the distribution conditions. The Issuer will monitor this.
  - **(On-Line Application)** on-line application form includes certain filtering questions and alerts including in certain circumstances prompting investors to seek further advice before progressing with the application. The Issuer will monitor this.
- Platform investors (IDPS):
  - The Issuer conducts periodic due diligence on its platform providers to ensure they have appropriate product governance procedures in place and only distributes through those Platform providers that meet those requirements.
  - Additional steps are not required for advised clients beyond consideration of the issuer's TMD by the adviser.
  - Unadvised clients may not be able to access the Fund unless the platform provider has a process where client is asked basic filtering questions relating to the TMD.
- Advised investors:
  - Investor to confirm through online application, they are financially advised.
  - Financial advisers to provide details of their AFS licence, including their adviser number from the Moneysmart website, and confirm they have reviewed and considered the TMD in providing personal advice to the investor.

  - mFunds Units are only available through the mFunds Settlement Service

Capital Growth	The consumer seeks to invest in a product designed to generate capital return. The consumer prefers exposure to growth assets (such as shares or property) or otherwise seeks an investment return above the current inflation rate.

<b>Consumer's Risk (ability to bear loss) and Return profile</b>	
<p>Issuers should undertake a comprehensive risk assessment for each product. The FSC recommends adoption of the Standard Risk Measure (SRM) to calculate the likely number of negative annual returns over a 20 year period, using the guidance and methodology outlined in the <i>Standard Risk Measure Guidance Paper For Trustees</i>. SRM is not a complete assessment of risk and potential loss. For example, it does not detail important issues such as the potential size of a negative return or that a positive return could still be less than a consumer requires to meet their investment objectives/needs. Issuers may wish to supplement the SRM methodology by also considering other risk factors. <b>Consumer's need to withdraw money</b>	
<p>Issuers should consider in the first instance the redemption request frequency under ordinary circumstances. However, the redemption request frequency is not the only consideration when determining the ability to meet the investor's requirement to access capital. To the extent that the liquidity of the underlying investments or possible liquidity constraints (e.g. ability to stagger or delay redemptions) could impact this, this is to be taken into consideration in completing this section.</p>	
Daily/Weekly/Monthly/Quarterly/Annually or longer	The consumer seeks to invest in a product which permits redemption requests at this frequency under ordinary circumstances and the issuer is typically able to meet that request within a reasonable period.
